Changes to Our Policies and Procedures

At the July 15, 2014 Board of Directors meeting, the Board made changes to the Policies and Procedures for Echo Canyon. We are legally obligated to notify owners of these changes by U.S. mail. These changes take effect 30 days after voted upon.

The Colorado Common Interest Ownership Act (CCIOA) regulates Homeowners Associations (HOAs) within the State of Colorado. Pursuant to Sections 38-33.3-16 (Lien for Assessment) and 38-33.3-316.3 (Collections), the Echo Canyon HOA is changing Sections 1.b.5.b and 1.b.6. of its Policies and Procedures to correspond with the CCIOA laws. Our current Policies and Procedures indicated that a resident would have a lien filed for non-payment of assessment after 90 days. We are changing it to say "after 180 days." The same applies for sending an account to collections (from 90 days to 180 days).

City of Fruita Ordinances

Noise Ordinance (Section 9.02.001) – The City has a noise ordinance. Quiet hours are from 9:00 p.m.-6:00 a.m. Please be a courteous neighbor.

<u>Temporary Street Parking (Section 8.15.020)</u> – Trailers and RVs may only be parked on the street for no longer than 12 hours.

If you notice a violation, please contact the police non-emergency dispatch number at 242-6707 to have an officer sent to the violator's home. You can request to remain anonymous.
