## 2011 Budget and Bids

- Proposed 2011 Budget
  - Motion/Second/Approved and Adopted
- Landscaping Bids
  - o CW Landscape Services, Inc.
    - Bid was for \$5750—\$6550 per year, dependent upon how many times pruning is done
  - High Desert Landscaping
    - Bid was for \$5660 per year
  - o High Performance Lawn Care (our current landscaping contractor)
    - Bid was for \$4380 per year.
      - Motion/Second/Pass to remain with High Performance Lawn Care
      - Board will review contract, and if changes are needed will work with Heritage and contractor to resolve.
- Management Company Bids
  - o Heritage Property & HOA Management
    - Currently paying \$256.00 per month for their services
    - As the Board does a lot of administrative work, we asked if our fees could be renegotiated.
    - Tracey will send a proposal with Heritage acting mostly as financial A/R A/P support, with some administrative support.
  - o A Better Alternative Management Company
    - Received a bid for their services at \$250 per month
    - \$6.00 less than what we pay our current management company
- Insurance Bids
  - Per Linda at Heritage, they did not send out bids for insurance:
    - Our current provider, American Family, has the lowest rates by far, and is one of the few providers in town who will insure HOA's.
