  - o Highlighted Article 1 Section 10 and Article III Section 1 of Covenants;
  - o These Homeowners disagree with Board asking no one to play in pond area; their argument is the covenants don't say this is not a play area.
- Don's response is:
  - o Pond area is designated for water collection;
  - No Trespassing signs were placed in the area for safety reasons;
  - O Homeowners should also refer to Covenants Article IX, Restrictions: Section 3: Use of Common Area and Irrigation System: c. The use of the Common Area or irrigation system shall be subject to such rules and regulations as may be adopted from time to time by the Board of Directors of the Association.
